Balephi Rural Municipality, Office of the Rural Municipal Executive, Balephi, Sindhupalchok invites sealed bids from Nepalese eligible bidders for the Upgrading Kathe Binjel Road under National Competitive Bidding procedures and intends to apply part of the funds to cover eligible payments under the Contract for BRM/NCB-05/2079-080, Upgrading Kathe Binjel Road. The estimated amount for the works is Rs.2434980.20 [inclusive VAT and PS].
- 2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Balephi Rural Municipality, Office of the Rural Municipal Executive, Balephi, Sindhupalchok.

- 4. Pre-bid meeting shall be held at office of Balephi Rural Municipality, Office of the Rural Municipal Executive, Balephi Sindhupalchok at 2079/07/04, 11:00 AM
- 5. Sealed or electronic bids must be submitted to the office Balephi Rural Municipality, Office of the Rural Municipal Executive, Balephi Sindhupalchok by hand on or before 12:00 PM on 2079/07/15. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:00 PM, 2079/07/15 at the office of Balephi Rural Municipality, Office of the Rural Municipal Executive, Balephi, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs.65,000 which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.


